NYAC was formed in June 1999 as the policy voice for addressing the needs and rights of young people and is convened by YANQ.

The role of NYAC is to share information, initiate research and develop campaign and advocacy strategies to retain a focus on critical public policy issues, which impact upon young people.

Unfortunately the Youth Minister, David Kemp, withdrew funding from a number of national peak organisations, including the national Youth Peak in 1999 and has not subsequently released monies for this vital new creative Coalition. NYAC is the Policy arm for the Australian Youth Affairs Network (AYAN) which has been in place since June 1999. Both AYAN and NYAC are unfunded and have received no financial support from the Department of Education and Youth Affairs (DETYA).

The ability for young people, especially disadvantage and marginalised young people, to have their voice heard regarding policy impacting upon them and to ensure policy advice to government is ongoing and supported by workers within their communities has been limited due to lack of funds.

Hundreds of young people and workers from across the country were involved in petitions, meetings, and letter writing and media announcements when Kemp defunded the National Youth Peak organisation. Young people want and need this support. Is the Federal government to scared too receive it?

What are young people and workers with young people supposed to do! Is the Federal Government not committed to understanding the plight of young people today? The Federal Government has effectively and without justification removed the community structure to support the needs of young people in our communities.

YANQ is very concerned that punitive federal policies, such as the Youth Allowance, will not be adequately evaluated without significant, coordinated input from the community sector"

All NYAC members met in Melbourne on the 26<sup>th</sup> June 2000 and re-committed to continuing their role as a voice for young people. It is now time for Youth Minister Kemp to fully support NYAC and AYAN as part of his portfolio responsibility. NYAC will meet again in Melbourne in November 2000.

NYAC members include Youth Affairs Network of Queensland (YANQ), Youth Action & Policy Association (YAPA), Youth Affairs Council of Victoria (YACVic), Youth Affairs Council of South Australia (YACSA), Youth Coalition of the ACT (YCACT), Youth Affairs Council of Western Australia (YACWA), Northern Territory Youth Affairs Network (NTYAN), Youth Network of Tasmania (YNOT), National Youth Coalition for Housing (NYCH), National Union of Students (NUS).

## Preventing Child Abuse and Neglect: Developing a National Research Strategy.

## Convention on the Rights of the Child

compliance of Convention's principles are directed at the Australian Government, a vital role is played by both government and non government organisations to connect these principles with ground level practices and policies the welfare sector. Considerable work remains to be undertaken with regard to proactively raising the awareness of the Convention. However many of the CROC articles can equally be applied to those young people over the age of eighteen years. Good Standards Test (GST), it is hoped that organisations, working with young people and children, will be encouraged to consider not only the ten questions as they apply to their service, but to critically evaluate the impact of CROC by considering the following broader questions:

- # How does Australia's commitment to meet the Convention impact on your organisation?
- # How does your organisation's commitment to meet the Convention impact on Australia's commitment?

- How do you see your role in relation to adhering to the Convention's princples?
- # How can your organisation assist in increasing young people's awareness of the Convention?
- # How can commitment to the Convention be monitored within your organisation?

While it would be easy for any organisation to answer all questions on the CROC GST with a 'yes', we encourage you to apply the questions to the most disadvantaged amongst your target group. For example, does the percentage of people from a non English speaking background accessing your service equal that percentage in your target group? Where and how we advertise may restrict access to some people and therefore may discriminate.

#### YANQ Centrelink Breaches Working Party

## Breaches Awareness Campaign

The Centrelink Breaches Working Party has been operational since late 1998. This working party has since combined with the Youth Allowance Working Party, given similar objectives relating to Youth Income support.

During 1999, the Centrelink Breaches Working Party applied for funds to conduct a Breaches Awareness Campaign. Success!!! Welfare Rights Centre (WRC) is auspicing the project, which is two-pronged. Firstly, training and information will be provided for youth workers. The objective is to assist youth workers to advocate on behalf of young people they are working with to appeal a decision by Centrelink to breach. Training will be conducted in a number of venues across regions in Queensland, from August until November, with the first workshop taking place in Warwick on August 2nd.

#### **Activity Test Evaluation**

YANQ is currently involved in the FaCS Community Reference Group (CRG) for the Activity Test Evaluation. The Federal Government emphasises the importance of a contract between the state/ community and income support recipients under the principle of mutual obligation. One of the clearest expressions of this contract is the activity test for those who receive income support. In general, unless specifically exempted from the activity test, to qualify for Youth Allowance or Newstart Allowance payments, a person must be either studying or actively looking for work. Given, amongst other things, that large numbers of young people are being breached, it is critical to look at whether activity testing and activity agreements are working, or not for young people.

A seat on the CRG enables YANQ to feed information on a range of issues for young people and activity testing.

- How appropriate are current activity test arrangements/ forms of assistance for young people, particularly disadvantaged marginalised young people?
- What other alternatives should be considered?

In light of Welfare Reform, government wants to know "How effective are current activity test arrangements/forms of assistance for young people in promoting economic and social participation?

Other considerations for discussion include:

- The notion of 'capacity to benefit' from assistance
- Short versus medium/long term focus for assistance
- Voluntary versus compulsory participation in activities
- Choice in relation to programs/ activities/jobs
- Promoting self reliance in individuals
- Tailoring assistance to the individual – individual support plans
- Case management, activity testing and monitoring participation

## **NESB/Youth Matters**

### From the NESB Policy and Network Officer

Four months into the position here at YANQ and I feel well and truly "on board" in the NESB Policy position and as a member of the wider team focus of YANQ's core business in the State.

As well as settling into the position and learning about the number of projects, groups and issues the NESB position is active in, it has also been a good period to "get out" and meet people and build relationships.

YANQ Interagency visits to the South East, Logan, Toowoomba, Redlands, Pine Rivers, Inner Urban and Inala Youth Inter-Agencies have been vital in meeting people and making contacts for the core priorities of YANQ and the NESB Policy Officers position.

Various Multi-cultural Networks such as those in Logan and the Inala - Ipswich corridor, and issue specific networks such as the Multicultural Health Network have again provided valuable contacts and the raising of issues to inform the NESB Policy Officers' work in collecting issues, continuing advocacy, and determining priorities for policy development.

Most recent visits to agencies such as MDA, Milpera, and QPASTT have also been important in understanding their work and role in the sector, collecting issues, and again to build relationships that are the foundation of our work and collaboration together.

Making regional contacts over the phone has also been helpful in building a knowledge base of who, where and what is occurring throughout the state youth sector.

And then there have been a number of core specific projects and issues of which the NESB Policy Officer is involved. A snap shot of some which have been highlighted in the last few weeks are -

#### Racism

Addressing the issue of racism remains one of the core components

to this position through Partners Against Racism.

In many ways, for society as a whole to develop any degree of unanimity on the nature of racism as a problem and development of strategies for dealing with it, requires continuing discussion, leadership and debate. Particularly in the area of developing strategies to address this issue, there needs to be a variety of long term approaches to make a difference on a grass roots level.

It is hard to suggest that any one particular strategy or policy in regard to racism will solve or negate the effects of racism in one simple act. As has recently been shown to occur, racist incidents may be triggered by events overseas, by changing economic conditions, by specific community incidents, by a host of moments which may be well out of the control of a specific community, ethnic grouping or individual.

A multifaceted approach and a variety of strategies to combat racism must constantly be developed to influence overall community and individual perceptions and culture from research and story telling, to community awareness projects, to public expressions of concern such as the previous Walk Against Racism event, the formation of regional and local networks to inform, support, and develop strategies, to continuing advocacy, lobbying and the development of policy to inform and guide responses to racism.

Later in the year, a research report for the Anti-discrimination Commission QLD on "Schools Response to Racism in Queensland" will provide an extraordinary snap-shot of the realities and stories of racially based incidents in some schools. The report will also highlight the extraordinarily positive responses that schools, communities and people are involved in to combat racism and celebrate our cultural diversity in the fullest sense. I foreshadow this future report to you and trust you will keep a lookout for the actual launch of the report later in the year.

The "Bridges to Understanding" forum project which features



elsewhere in this edition of Network Noise, is another forthcoming response to the issue of racism, and I also commend you to this occasion and the significant inroads the forum will enable.

#### Reconciliation

The Brisbane People's Walk for Reconciliation on June 4th, was an amazing and soul searching occasion. One of my lasting images is of standing in King George Square (which was packed like a sardine tin) and looking back up Roma Street to see yet more people who were continuing to make their way to the Square. There was an tangible positive spirit to this mass of people and also a sense of reflection and pilgrimage as we walked the walk. This was a significant event for reconciliation in this land and demonstrated, I believe, the passionate desire for the continuing reconciliation process.

#### ESL

The further development and advocacy for ESL services in Queensland also remains a key focus of this position. Recently a comprehensive review of MOLTE was begun in the Coopers Plains Educational District. This process will assist schools to examine their current processes, the effectiveness of their programs and how they might be able to achieve better outcomes for students. Significant learning's and practices will development from this review and enhance our educational offerings to culturally diverse young people.

#### Temporary Protection Visa's

The designation of the TPV category has created, what is basically for me, an underclass of refugee / asylum seekers in Australia and also given rise to a variety of myths and ignorance regarding the status of these TPV holders in the general public.

These refugees (primarily at the present time from Afghanistan and Iraq) are not "illegal Immigrants" or "queue jumpers" and have been granted refugee status in Australia through the issuing of the TPV – yet their treatment is of enormous

concern and the lack of understanding about these people's situation has been fueled somewhat by ignorant media propaganda.

At a recent public forum in Brisbane, the forum asked the State Government to provide low cost housing, access to English classes, access to interpreters and translators, assistance in finding employment, and to explore ways in which these refugees can make some contact with their families. All of these are basic human rights which, in many ways, these TPV holders are being denied by the Federal Government under their TPV status. This raises the issue of violation of their basic human rights and is yet another indictment on the international image of Australia in terms of social justice.

And then wider questions have been raised in relation to whether their treatment is racial and religious discrimination and practical concerns about what will happen after three years temporary status expires.

The need for continued community collaboration and lobbying and actions to address the status of TPV holders and enable them to have their basic human rights and needs met is an important priority.

#### QLD Community Relations Plan Working Group

The working group on the Queensland's Government Community Relations Plan is busy developing an action plan for the implementation of the CRP. The plan will enhance community building activities with Government agencies and provide examples for the wider community. The Implementation of the plan will also benefit all Queenslanders with outcomes including a broader acceptance and understanding of diversity in the community; reduction in levels of discrimination and prejudice; and increased awareness of rights, responsibilities and opportunities of citizenship.

#### The NESB Youth Issues Network

The last couple of months has also seen significant work in the updating of contacts for the Non English Speaking Background Youth Issues Network (NYIN). This has also included understanding and coming to grips with a number of smaller focus or sub-groups which relate to NYIN and the core responsibilities of the NESB Policy Officers position. While this has been sometimes a complex and tedious task, it has been vital and necessary preparation for a shortly to be called network meeting which I hope will be the beginning of a renewed and re-energized network. the raising of core issues to be addressed, and new beginning's for significant outcomes in the area of policy development.

#### **Bridges to Understanding**

*Bridges to Understanding* is a joint initiative between Caloundra Community Centre, Youth Affairs Network of Queensland and a number of other government and non-government agencies on the Sunshine Coast. The project has received funding from Multicultural Affairs Queensland (MAQ).

The development of the project has been influenced by previous research undertaken on the Sunshine Coast by Tu'ipulotu and Ferguson (1997) which clearly identified racism as a significant issue impacting on the lives of many non-English speaking background young people. The group responsible for the implementation of recommendations regarding racism in this research report is the Multicultural Youth Issues Working Group (MYIWG) which is a sub-group of the Sunshine Coast Youth Workers Forum. The MYIWG is a key player in the development and implementation of Bridges to Understanding.

Caloundra Community Centre will be hosting a one day forum at the Rydges Oasis Resort on September 1st 2000 to explore the issue of racism and its impacts on individuals and communities. This forum is the culmination of the *Bridges to Understanding* project.

Leanne Tu'ipulotu, Manager of the Caloundra Community Centre, said "Bridges to Understanding is a community education project that aims to promote a broader acceptance and understanding of cultural diversity and reduce racism and discrimination across the Sunshine Coast. The one day forum provides us with opportunities to bring a whole range of people together in the one place to explore issues of racism and discrimination in our communities and potential ways in which we can work alongside one another to prevent such destructive issues impacting on so many."

The Bridges to Understanding project has also developed a series of workshops with young people on the Sunshine Coast, which explored the issue of racism. From this process a poster was produced for wide distribution across Sunshine Coast communities. The poster will be launched during the form.

Department of Corrective Services have recently reviewed the Corrective Services Act 1988. Although the review is needed **Sisters Inside seeks your active support** to lobby against and stop s26(1) of the Corrective Services Bill. This section ensures with legal authority that the person in charge of a secure prison must ensure that a woman is **strip searched** after a personal contact visit (these visits are with children, mother, families).

Statistics prove that over 85% of women in prison have been sexually assaulted. This legal systematic sexual assault will retraumatise these women again and again. Women are not in prison to be systematically sexually assaulted by the State in the name of the law. Assault is illegal however sexually assaulting women in prison will be legal under this reviewed Act. Strip searching is justified under the Drug Strategy however in 5 months 1472 strip searches were executed on women in prison at Wacol (including a baby) and not one piece of contraband was found. Strip searching does not stop drugs in prison.

To ensure we, as communities do not support sexual assault by the state we must take action now and say **NO** to this government.

#### LOCAL GOVERNMENT ASSOCIATION OF QUEENSLAND INC.

Young People in Public Space – Legislation and Policy Review

The Local Government
Association of Queensland
(LGAQ) has received State
Government funding through
FYCCQ to undertake a Young
People and Public Spaces Project
to build the capacity of local
government to respond to young
people and public space issues.

A component of this project is to undertake a policy and legislation review to identify federal, state and local government laws that impact on young people, in particular their relationship to and use of public space. In addition to the review the work will document common issues of concern and the interrelationships between state and local laws, and gaps in legislation and/or policy and provide and analysis of these legislations within a youth rights framework as articulated through Australia's ratification of international conventions and charters. This review and analysis will inform the development of a policy and local law framework for local government to assist Councils developing responses to public space issues. LGAQ will work in partnership with the Youth Advocacy Centre (YAC) to undertake this work.

#### **Project Outputs**

- Report including:
  - audit of existing federal, state and local policies and legislations;
  - analysisof interrelationship between these;
  - analysis of these within a youth rights framework.
- Reference tool to assist Councils in developing their local laws.
- Development of information sheets for Councils on existing policies, laws and legislations.

#### Project Management

The project will be managed by LGAQ with a project advisory team comprising of representatives from LGAQ, YAC, BCC, DCILGPS, YANQ, FYCCQ,, Crime Prevention Queensland, Local Government and Legal Aid.

#### Police Move-On Powers

Police Minister, Tom Barton tabled the Police Powers & Responsibilities Bill 2000 in Parliament on 29<sup>th</sup> February 2000. The Police Powers and Responsibilities Act (PPRA) 2000 was passed by the Queensland Parliament on 16<sup>th</sup> March 2000. This legislation builds on the PPRA 1997. The Bill extends the current move-on provisions to cover malls in Queensland. Police will have the power to move someone on if they consider the person's presence causes "anxiety" to another person.

There was no consultation undertaken with youth sector representatives prior to the tabling of the Bill. This Bill, in fact, is incongruent with other State Government's policies such as the Youth Participation Strategy. Young people have a right to participate in our communities, however, the impact of these extended powers has the potential to infringe on young people's rights and the rights of disadvantaged and marginalised groups, to access public space.

Both YANQ and Youth Advocacy Centre (YAC) are involved in gathering information – anecdotal, written and research in order to continue informing and lobbying State government regarding the negative impacts that will continue as a result of the further extension of move-on powers. Stay tuned...

## Youth Participation Strategy

We were pleased to finally see some resources announced in the recent State Budget attached to the Local Level Participation component of 'Generate'.

YANO has also been invited to nominate as a member of the State Youth Advisory Council (SYAC). We analyzed the current information released on 'Generate' and are pleased to let members know that the majority of feedback seems to have been actioned eg. There will not be a register of young people; the website will be utilised for communication not consultation and the SYAC will focus on youth participation models not advising on policy. Therefore YANO has nominated as a member of the SYAC so we can keep the sector informed on the process and support young people with information. We have not yet heard the outcome of our nomination.

#### **Membership Survey:**

Thank-you to all members who have returned membership surveys. We are currently analyzing the data and will distribute findings in a report in the next couple of months.

#### **Feedback Processes**

We have finally received final approval of the new Constitution from the Office of Fair Trading on the 6<sup>th</sup> April 2000. We are therefore in the process of implementing new membership forms to include the new information.

#### Have Your say in the Industry Training Analysis

The Queensland Community Services & Health Industries Training Council (ITC) is conducting its annual Industry Training Analysis....and we need your input.

Each year, the ITC is responsible for conducting an industry training analysis, which is used to advise the Department of Education, Training and Industrial Relations (DETIR). The report is due to be completed by Septemebr, 2000 for consideration in the 2001-2002 resources allocations of publicly subsidised training across all industries. The report will provide information to the Department on:

- > Current training arrangements
- > Adequacy of current training arrangements
- Access issues in relation to training
- Potential training gaps
- Where the training will be required in the future

The advice provided will inform a number of publicly subsidised funding areas within DETIR which include TAFE allocations, contestable funds to all eligible registered training organisations, apprenticeships / traineeships, and access & equity allocations (that have a number or targeted funding strategies to support people with disabilities, rural and remote communities, indigenous people, volunteers, women and people from a non-English speaking background).

The planned allocation of training funds for the community services industries in 2001-2002 is 10.96% of the total budget (as for 99) so no growth in overall funding is apparent. This means that considered attention and prioritising by all sectors and regions will be needed including an analysis of other existing/potential sources of funding to address broader training needs.

#### **QGYSPS Brisbane South**

Project Title: Referral Pathways of Care across Brisbane South

The Brisbane South Metropolitan area contains a diverse collection of marginalised neighbourhoods. Populations include indigenous, remote (islanders), multicultural communities. One of the outcomes of this innovative project will be acknowledging the diversity and enhancing the respect for existing services, so that it contributes to an overall sense of nationhood. This project presents a shared vision, a framework for cooperation and a basis for coordinated action to reduce youth suicide which will improve the health, social and economic outcomes for both the community and young people.

With the implementation of these protocols, services which currently work independently of each other, and therefore disconnectedly shall in future provide an effective continuum of care referral pathway for young people with self harming/ suicidal behaviours. This is in line with the Ottawa Charter rationale and strategy, which focuses on improving the health outcomes through strategies such as this project. By embedding changes in the community through this process, community action strengthened and health services are reorientated. In effect it will promote sustainability and enhance community 'connectedness', thereby caring for the present and future generations of young people. This project is unique in that it addresses issues identified by communities, enhances existing services and increases the communities' capacity to respond to young people at risk across a large population base.

The Brisbane South District Steering committees of the Queensland Government Youth Suicide Prevention Strategy have identified the need for working collaboratively with acute mental health services, hospitals and community organisations to develop and implement good practice protocols on referral pathways of care for young people engaging in self harming/ suicidal behaviours.

The project seeks to:

- Establish a process for coordination, planning and development
- Identify issues, gaps and strengths of services in the Brisbane South Area, including training, policies, protocols and referral strategies
- Assist the community to gain relevant knowledge of what services exist for young people at risk of suicide and self harm
- Encourage and support agencies and services to review, develop and implement policies, protocols and standards to facilitate evidenced based practice, to those working in response to young people at risk of suicide and self harm
- Develop and enhance communication systems between relevant agencies in Brisbane South to facilitate timely referral of young people at risk.

### YOUTH DRUG AND ALCOHOL NETWORK PROJECT

The Youth Drug and Alcohol Network Project was initiated after the State Youth Drug & Alcohol Summit held in 1999 is continuing throughout 2000 and into 2001. I have recently been employed to commence Stage 2 of this particularly exciting project.

My role is to coordinate stage 2 of this project. I say exciting because funds are being channeled directly to 20 youth networks across the state to develop a participation process that will actively engage and involve young people in a meaningful way to promote and represent their views and experiences. This is a joint project with the Aboriginal Coordinating Council which will coordinate four projects in North Queensland funded by Qld Health.

Stage 1 of the project saw the involvement of YANQ through the Alcohol and Drug Summit's steering committee and the planning and implementation of the Practitioner Workshop at the Summit. Marg Strong and James Finn were contracted to conduct the planning and facilitation process of this in 1999. The main aim of this stage was to assist workers in the field to identify and share their stories in order to develop good practice models.

One of the key action plans was to develop a safe process to enable young people to participate and share their experiences. To this end stage 2 will involve the 20 projects selected from the 1999 Drug and Alcohol Summit being resourced and supported to work with their networks to:

- ⇒ develop a project that expresses and represents young peoples experiences, feelings and views,
- to participate in the Zombie Web Internet program which is being implemented by Queensland Health to connect young people across the state via the internet to share their stories and keep in touch

Finally, the networks will assist in

the planning, supporting and conducting of the Youth Drug and Alcohol Summit which is stage 3 of the project being planned for September/October 2001.

## Innovations by the Youth Interagencies

Inner Urban Youth Interagency Youth Homelessness Research Project

The Inner Urban Youth Interagency is a coalition of services working with young people in the inner city (within an 8-km radius of the CBD), as well as Local and State Government representatives. The Interagency has secured funding from the Brisbane City Council Community Development Assistance Grant program to conduct a research project focussing on homeless young people who access outreach services after hours.

The project will be conducted in two stages and will assist services involved in the interagency to 'get a clear sense of who is homeless in the inner urban area, what the issues are for these young people and what services are required to respond'. Young people will be surveyed during two periods, one week in August and one week in November, in order to gain a comparison of the colder and warmer times of year.

#### **AGE MATTERS:**

### A REPORT ON AGE DISCRIMINATION IN AUSTRALIA

Federal anti-discrimination legislation is needed to eliminate unfair treatment of Australian workers based on their age, Human Rights Commissioner Chris Sidoti said today.

Launching his report, Age Matters: a report on age discrimination, Mr Sidoti said age was still being used as a criterion to judge a person's ability to do a job.

"There is now substantial research that shows older and younger workers feel they are denied promotion, employment and training because of their age," he said.

He called for funding of specialist employment agencies to help place older Australians in work and a national public and business awareness campaign. He also said young people face discrimination, in some cases being told point blank they are too young for the job.

"Ironically, people get hit at both ends of the spectrum," he said. "At 16 we may be thought too young to perform a certain job. Several decades on we are often judged too old to do certain jobs."

The Australian Defence Force was highlighted as an area of Government employment with strict age limits covering recruitment, promotion and duration of employment. In four recent complaints about ADF employment practices, Mr Sidoti found the ADF had unjustly discriminated against the men. The ADF is in the process of reviewing some of its age limits.

Mr Sidoti called for federal anti-discrimination legislation that would make age distinctions unlawful unless reasonable or justified.

"For over 10 years Governments of both political persuasions have talked about this but done little," he said. "The situation now is that the Commonwealth lags far behind every state and territory in protecting people from discrimination based on age."

#### Summary of our Values

At YANQ, we believe that everyone is unique. At the same time, human beings share a lot in common, and are essentially social. We envisage a society where everyone lives in harmony. For this to happen, society must both value every individual and seek the best outcome for the community as a whole. There is the same diversity amongst young people as the rest of the community; like everyone else, young people need to feel respected and valued. When young women and young men are treated as important, the rest of society will gain from their insights and experiences.

We aim to contribute to developing a society that genuinely includes all its members. That's why we are committed to promoting multiculturalism (in its widest sense), and supporting and respecting the wide range of cultures that are part of Australian society. Aboriginal and Torres Strait Islander people always have been, and always will be, the first people of this land. Because of their special relationship with the land, indigenous culture will always have a particular significance in Australian society. Focussing on reconciliation with indigenous people is an important starting point toward creating a more inclusive society. It also provides a model for other areas of action, including strategies toward improving the situation of young people.

We believe that the most effective way to achieve constructive social change is for people to work together. Economic, social and political change is happening all the time, and it is critical that we constantly assess and reassess our strategies if we are to influence change. Both the process and outcomes of change must be fair if sustained, constructive social change is to occur

We believe that everybody is entitled to have their basic emotional and material rights met. The central role of governments is to ensure that this occurs. Unfortunately, at the moment, governments in Australia focus on supporting global economic interests. Whilst we believe that everyone is fundamentally equal, some sections of our society do not have access to their fair share of society's resources. This includes young people, whose basic human rights are currently not being met. YANQ is committed to encouraging positive discrimination on behalf of those groups which miss out in society so that this type of social injustice will be overcome. It is only when everyone's fundamental rights are fulfilled, and each has the means to fully participate, that it will become relevant to talk about "mutual obligation" between society and its members.

We believe that a range of strategies is required to achieve constructive social change. Governments in Australia appear committed to stopping the voice of those who challenge their misplaced priorities. YANQ is responsible for being a strong public voice which lobbies and advocates on behalf of those young people who particularly miss out in society, and of young people as a whole. To undertake this role effectively, it is crucial that we draw on the expertise of those working most closely with issues affecting particular groups of young people - young women and young men themselves, youth workers and youth organisations. That's why networking is another important social change strategy; it enables the youth sector to participate in collective action.

#### WHAT IS THE AMEP?

The AMEP is funded federally by the Department of Immigration and Multicultural Affairs (DIMA) and delivered in flexible modes across Australia by providers who are specialists in teaching English as a second language such as TAFE QUEENSLAND.

The AMEP is aimed at assisting in the settlement process and the acquisition of English language skills for newly and recently arrived adult migrants.

The AMEP is accessible through Formal Classroom Tuition, Home Tutor schemes and Distance Learning.

#### COST?

Enrolment in AMEP courses is FREE as there are no course fees for eligible clients. (For clients on certain visa subclasses and NZ passports there is however an annual administration fee or proof of exemption)

AMEP Eligible clients are entitled to FREE child care for children under school age, where it is required in order to attend class. *Conditions apply*.

#### WHO IS ELIGIBLE?

There are certain criteria, depending on visa category, which a client requires to be ELIGIBLE for the AMEP. Generally the following categories of people are eligible when assessed as not yet functional in English:

- Migrants who arrived in Australia after 1<sup>st</sup> July 1991;
- > Newly arrived migrants or humanitarian entrants;
- > Temporary residents who hold a gazetted visa class;
- Migrants on New Zealand passports;
- ➤ People who have been granted permanent residence in Australia since 1<sup>st</sup> July 1991.


